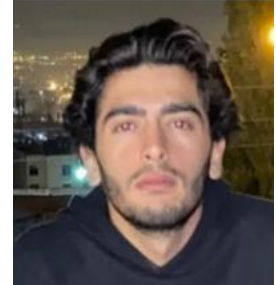

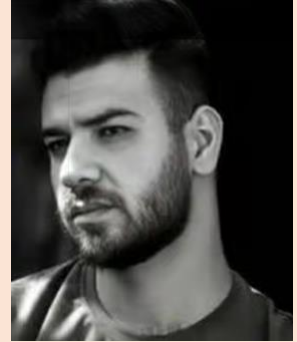

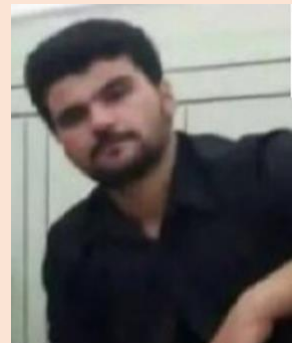

According to a prisoner who heard from Habib: "*Habib said that the IRGC interrogators tied my legs and lifted me up. While my head was facing down, they repeatedly submerged my head in water while I was hanging. Sometimes, with my hands and feet tied, they placed a towel over my face and poured water on it, making me feel suffocated, and they repeated these actions over and over again. These tortures were different from those involving cables and wires. They beat me so severely with green cables and tubes that my body was bruised, bloody, and my skin was torn off*".

Azizi is a citizen of Mahabada-Kurdistan and former political prisoner. She was arrested on 16/11/2009 and four months later she was released on bail.

**Update:** (04/08/2023) Pakhshan was arrested along with her family and transferred to section 209 of Evin Prison. Two weeks later after Pakhshan's hunger strike, her family was released on bail.

**Update:** (23/07/2024) Pakhshan Azizi has been sentenced to death by Branch 26 of Tehran's Revolutionary Court, presided over by Judge Iman Afshari, on charges including 'membership in opposition groups'.

**Update:** (24/07/2024) The majority of female political prisoners in the women's ward with various beliefs collectively protested in the yard of this ward against the issuance of the death sentence for Pakhshan Azizi.

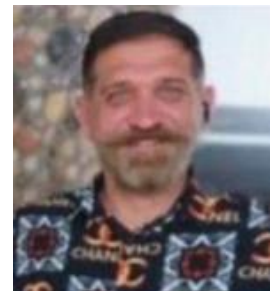

**Update: (12/08/2023),** Mostafa Ahmadian, the defense lawyer, posted on Instagram: "The case of my client, Mr. Pouria Javaheri, a young man from Kamiyaran, who has been in prison since November of last year under an arrest warrant, during the nationwide protests. The indictment has been submitted to the Sanandaj Revolutionary Court, and we are awaiting the hearing. Master Mohammad Khazar Nejad is a Suni cleric from Bukan, accused of "harming the integrity and independence of the country" and "propaganda against the regime". He was arrested on 19/11/2023 after giving a speech at the memorial ceremony for Asad Rahimi, one of the victims of the "Women, Life, Freedom" protests in Bukan.

**Update:** (06/06/2024), The Supreme Court confirmed the death sentence and 16 years in prison of Mohammad Khazar Nezhad

**Update:** (12/06/2024), The regime's news agencies have announced that Khazar Nejad's death sentence has been reduced to prison, but so far this political prisoner and his lawyer have not been officially informed about the cancellation of the death sentence.

## Hatam Ozdmir (Hatem Ozdemir)

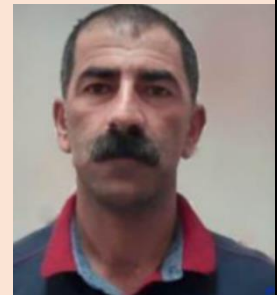


**Update:** (23/04/2024) Hatam Ozdmir, is a Kurdish citizen of Türkiyea Kurdish, was arrested in July 2019 after being ambushed by the IRGC near the Iran-Türkiye border. He was sentenced to death by the third chamber of the Urmia *Revolutionary Court*, presided by Judge Najafzadeh, accused of "War against God".

During his five years of imprisonment, Ozdemir has been denied adequate medical care, including treatment for kidney stones, despite doctors recommending surgery.

## Nayeb Askari

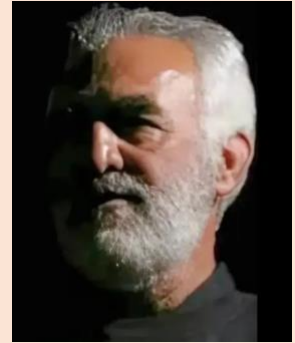


**Update:** (16/10/2023) Naib was sentenced to death by the second chamber of the Revolutionary Court of Urmia, accused of treason. On Monday, October 16th, he was summoned to the prison office at Urmia Central Prison, where he was officially notified in writing of the verdict. On September 24th, the final hearing on the charges of this political prisoner was conducted without the right to have legal representation.

**Update:** (27/03/2024) He had an argument with the prison officials, which led to him being sent to solitary confinement, sparking fears among his family that his execution may be imminent. Fortunately, one day later, he was returned to the general prison population at Urmia prison.

## Shahryar bayat

Shahriar Bayat was arrested for defending the Woman Life Freedom movement on social networks and was accused of insulting the Prophet of Islam. According to Article 262 of the Islamic Penal Code, if anyone insults the Prophet of Islam, he will be charged with "blasphemy" and sentenced to death.

**Update:** (14/02/2024) Section 13 of the Tehran Criminal Court has sentenced Shahryar Bayat to be publicly hanged.

## Yusef Ahmadi

Yousef, along with three other Kurdish citizens, Mohammad Karimi, Basit Karimi, and Mohammad Faizi, was arrested on 27/04/2020 in the city of Baneh. This citizen was shot by security forces while they were detaining him, sustaining a gunshot wound to the leg, and was subsequently transferred to the detention center of Sanandaj. In 1402, this political prisoner was sentenced to death by the first section of the Islamic Revolutionary Court in Sanandaj, accused of "treason" for being affiliated with one of the Kurdish opposition parties and "participating in the murder of two members of IRGC.

**Update:** (25/01/2024) The Supreme Court has upheld the death sentence of Yusef Ahmadi.

In April 2016, Ahmad Reza Jalali traveled to Iran at the invitation of the University of Tehran and Shiraz University to participate in a crisis management study. He was arrested by agents of the Islamic Revolutionary Guard Corps (IRGC).

The IRGC accused Ahmad Reza of espionage for Israel, alleging that he provided information to Mossad about the two Iranian nuclear scientists killed in Tehran in 2009-2010, Masoud Alimohammadi and Majid Shahriari.

AhmadReza's death sentence case seemed to be on hold, but in the last week of April 2024, his family warned about the risk of execution, and various actions were taken:

He has also been accused of being a spy for Western Intelligence. His family deny all accusations. His abduction is one of a series of kidnappings carried out by the Islamic Republic of Iran. He is member of the Kingdom Assembly of Iran.

**Update:** (16/07/2023) Ghazleh Sharmahd, the daughter of Jamshid Sharmahd, shared details of an unexpected phone call. She expressed concern that her father was unaware of his death sentence and questioned whether this call would serve as his final farewell.

Reza's relatives have vehemently denied this accusation. He was subjected to brutal torture to obtain coerced confessions, and on the day of the trial, he didn't even recognize his own family and couldn't defend himself properly. Reza belongs to the religious minority of Yarsanis in Iran, who have been subjected to discrimination and repression by the regime.

**Update: (07/10/2023)** Branch 2 of the Kermanshah Criminal Court has sentenced Reza to death.

**Update: (24/12/2023)** Masih Alinejad called for widespread support for Reza Rasai, stating, "Reza Rasai has endured so much that he is unrecognizable, with broken teeth and fingers. The Islamic Republic employs this tactic to intimidate its opponents."

**Update: (31/12/2023)** Rezaei Rasai's death sentence, passed by the 17th Chamber of the Supreme Court on December 25, on 31/12 was sent to the Kermanshah Criminal Court for execution.

**Update: (06/01/2024)** Reza has been allowed an in-person visit with his family. Until now, visits had to take place in a cabin.

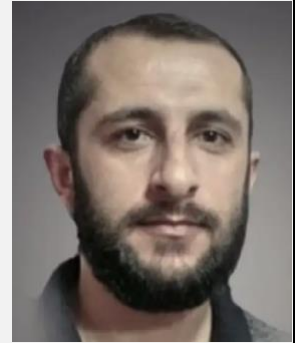
