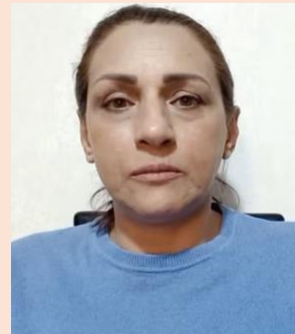

He is later released on bail. On 19/01/2023 she was interrogated by the Pasdaran intelligence committee. Around the 10/2023 she was arrested along with 3 other human rights activists.

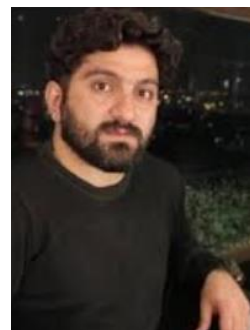

Reza was arrested on 11/24/2022, just a few days after the anniversary of the murder of Khalil Ali Nejad, a Kurdish musician and singer. He is charged with "war against God" in relation to the assassination of Nader Bayrami, an intelligence commander of the Revolutionary Guard (Pasdaran) in the city of Sahne. Reza's relatives have vehemently denied this accusation.

He was subjected to brutal torture to obtain coerced confessions, and on the day of the trial, he didn't even recognize his own family and couldn't defend himself properly.

Reza belongs to the religious minority of Yarsanis in Iran, who have been subjected to discrimination and repression by the regime.

Update: (07/10/2023) Branch 2 of the Kermanshah Criminal Court has sentenced Reza to death.

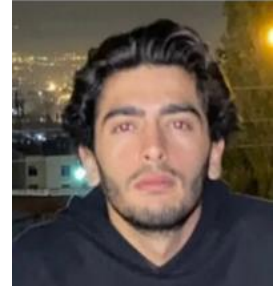

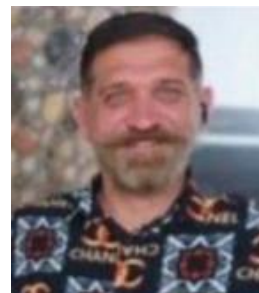


Saman Kheznejad, was arrested in July 2023 in the protests in Marivan by the Islamic Revolutionary Guard Corps (IRGC). Following his arrest, he was transferred to Urmia and has been held in the IRGC detention centre ever since. Since his arrest, Saman has been denied his fundamental rights, including the right to choose a lawyer and the opportunity to visit his family. He reportedly faces serious and hefty charges, including "Waging War against God" and "Blasphemy", which could result in the death penalty.

Tragically, his mother passed away in late August 2023, and he was not allowed to visit her for a final farewell.

Update: (17/10/2023) Freshteh Tabanian, lawyer of Abbas Drees: the order to suspend the execution of the sentence was sent to room number 1 of the court of Mahshahr. The judge has set a bail of 800000€ !

A letter written by the son of Abbas:

I am Ali Drees, the eldest son of Abbas and Kefaye. Upon hearing the devastating news of my father's death sentence, my mother suffered a stroke and has left us alone. Now, my father's life is in grave danger, and my brothers Mehdi, aged 12, and Mohammad, aged 8, and I are left wondering if this world can be so cruel as to take our father away from us too. The three of us, as children, implore all organizations, governments, kind-hearted individuals worldwide, and even the children of the world help prevent the execution of my father. This situation is utterly distressing, and we desperately seek your assistance in bringing our father back home.

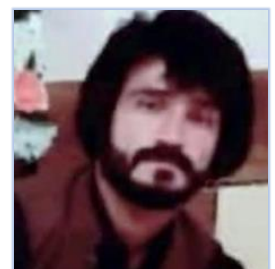

His father says more than 50 people have signed an affidavit testifying that Pouria was in his village and not in Kamyaran the day a Basij/volunteer militia was killed (what he is accused of). Update: (12/08/2023), Mustafa Ahmadian, the defense lawyer, posted on Instagram: "The case of my client, Mr. Pouria Javaheri, a young man from Kamiyaran, who has been in prison since November of last year under an arrest warrant, during the nationwide protests. The indictment has been submitted to the Sanandaj Revolutionary Court, and we are awaiting the hearing. The charges attributed to my client include ' War against God' , 'the assassination of a military personnel', 'membership in groups opposed to the system', and 'propaganda activity against the system'.

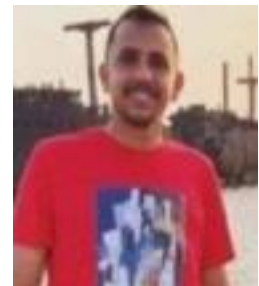
He was born in Tehran and moved with his family to Hanover, Germany when he was 7 years old. He has been a German citizen since 1995. He established his own software company and in 2003 moved to the United States, where he is a legal resident. The Iranian government alleges that Sharmahd is responsible for a 2008 attack on a mosque in Shiraz that killed 14 people and injured 200. He has also been accused of being a spy for Western Intelligence. His family deny all accusations. His abduction is one of a series of kidnappings carried out by the Islamic Republic of Iran.

Update: (02/08/2023) SAMAN was transferred from Rajaei Shahr Prison (Karaj) to the Evin Prison (Tehran). There are no more information about the reason of this transfer.
